FRANK MARTIN (Vice-president)

• Grew up in Surrey Hills (Melbourne). Attended Surrey Hills primary and Box Hill high schools before completing an electrical engineering diploma at Royal Melbourne Institute of Technology and an engineering degree at Melbourne University.



- Frank worked for 30 years at the State Electricity Commission of Victoria (SECV) – at Thomastown terminal station (north of Melbourne), Rubicon hydro-power stations (near Eildon), Hazelwood power station, Yallourn W power station, Loy Yang A power station and in many Melbourne offices.
- In 1974 he was selected to work for 12 months overseas so, with Jocelyn and their small children, Heather and Richard, he travelled to Germany. While working in their power stations, he lived in small villages, and travelled throughout Europe on weekends and holidays.
- Frank's final SECV role was based in the Latrobe Valley as general manager of operations across all power-generating stations in the State. This ceased when the SECV was privatised.
- Since purchasing the Parlours' hardware business in Cobden in 1995, Frank and Jocelyn have operated Cobden Home Timber & Hardware, and Timboon Hardware since 1996.
